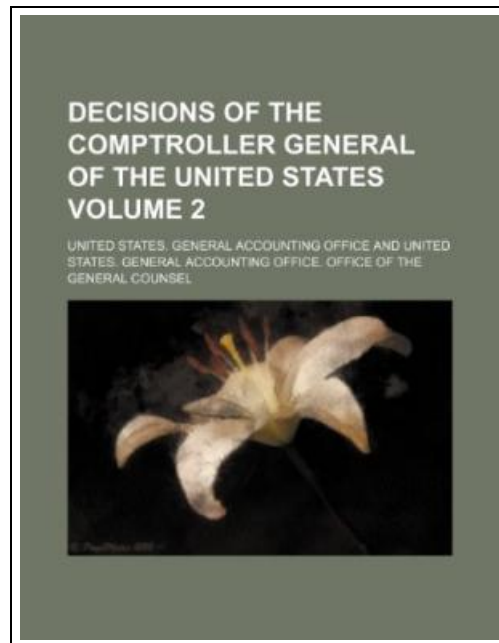

If it is to be understood from this expression that in the opinion of the Acting Attorney General it is no concern of the General Accounting Office whether payments from public funds are made on unauthorized and unlawful awards of the commission the assumption suggested above is warranted, the conclusion of the opinion is incorrect, and, should it be understood by the commission and its disbursing officer as authority for disregarding the decision of this office, may result in large unauthorized expenditures of public funds on unlawful awards, recovery of which sums may prove most difficult, if not impossible.
